NOTE: If **ethics** is to be created in REGIS, the **ethics** application will be generated first. Once submitted, site applications will be generated. If ethics is external to REGIS, site applications will be generated upon submission of the project registration.

- If you have already received approval from an HREC or your application is currently under review, select “Yes” to **QA1**. (Further questions will be displayed for you to respond.)
- If you are submitting a low-risk ethics application to the Tasmanian DoH LRR Ethics Committee, select “No” to **QA1**. (If you select "No", REGIS will create an ethics application for you to submit to the TAS DoH Health LRR, NSW or ACT HREC for ethics review.)
- If your project is higher risk, contact the research ethics office for advice on the most appropriate HREC to submit your ethics application (UTAS HREC or an NMA HREC).
